CET-2017 – Important Instructions –AYUSH (ISMH) / B.Sc. (Agriculture) / Veterinary (Farm
Science) Seat allotment - Option Entry Schedule
No. ED/KEA/ADMN/CR-18/2016-17 Date: 13-09-2017

ISMH, Agriculture and Veterinary seats which are canceled / newly added / identified as not reported if any, will be offered in this round to the eligible candidates as per the following schedule. College wise, Category Wise and Course wise detailed Seat Matrix is hosted on the KEA Website <http://kea.kar.nic.in> along with the fee structure. In addition to the above mentioned seats, the AYUSH, Agriculture and Veterinary consequential seats which may arise during the seat allotment will also be offered in this round. Interested eligible candidates can exercise their options afresh as per the schedule to become eligible for allotment of seats in the order of merit.

1. In this round the eligible candidates have to enter their priority of options afresh. (Fresh Option Entry) Earlier Options will not be considered.
2. Candidates are advised to enter the options they want to select whether the seats shown in the seat matrix or not, only for the reason that ISMH / Agriculture / Veterinary consequential vacancies (movement seats will also be considered for allotment) may arise during allotment process and the candidates will have a chance of getting a better seat if they have entered the options.
3. Candidates who are already admitted to colleges are advised to attend this round **only if they are interested** and after confirming of getting the original documents within the stipulated time from the present college. The seat selected by the candidates in any discipline will get cancelled automatically upon allotment of a seat in this round and for any reason they will not get back the old seat but to compulsorily join the allotted colleges.
4. The responsibility of obtaining the original documents from the present college for admitting to the newly allotted college within the stipulated date and time solely lies with the candidates.
5. All other guidelines and procedures given in the CET-2017 brochure remain same for all other purposes.

CAUTION: The candidates who are admitted to the college and pursuing their studies in the college are here by informed to participate in this round in consultation with their parents and only if they are interested in AYUSH / Agriculture / Veterinary courses. The seat held by them will get cancelled automatically upon selection of a seat in this round and for any reason **they will not be eligible to continue in the college** allotted to them in the earlier rounds. Candidates have to compulsory report to the allotted college on or before the last date prescribed and if a candidate fails to report to the allotted college they will not be having any seat in their favour; they will lose both the seats and fee will not be refunded. **After the seat allotment in this round candidate has to compulsorily report to the allotted college.**

Following types of candidates are not eligible to participate in this round

1. Medical seat once allotted candidates.
2. Candidates admitted to Dental colleges.
3. Veterinary seat once allotted candidates.
4. Candidates admitted to Engineering colleges.
5. Allotted AYUSH / Farm Science seat but cancelled the seats.
6. Allotted AYUSH / Farm Science seat, but failed to pay the prescribed fees.
