1. The treatment should cover for Mosquities, Flies, cockroaches, rats, red and blank ants and similar other crawling insects. It should comprise of thorough insecticidal spray of the entire premises especially in all nooks & corners & other vulnerable places harbouring cockroaches. The treatment should include rodent control & termite control both Internal & External;
2. SIPC Control Gel treatment for cockroach, IPM Techniques for mosquitoes and flies, Rodokill treatment for rodents, burrow fumigation, disinfestations odorless spray treatment for house hold crawling pest.
3. The agency should be professionally managed having adequately trained and equipped staff who would have at least three year experience in the field of providing service;
4. The cost and the service charges should have been clearly mentioned in the contract and there should not be any provision for hidden cost/charges to be included in the contract subsequently;
5. The visiting for the Pest control service should be on the appointed date and any deviation from that date should be informed three days before the scheduled date;
6. Service work will be performed during regular working hours.
7. The contract shall remain in force for a period of one year from the date of issue of the letter awarding the contract;
8. The agency shall be at liberty to inspect the premises on any working day during working hours after prior appointment from the Administration;
9. In case the service is found to be unsatisfactory, the contract will be terminated without assigning any reason;
