PG AYUSH -2018 - Second Round Seat Allotment

**A) Online registration and Verification for PG AYUSH courses**

1. In view of the letter dated 02-11-2018 AYUSH Department, lowering the qualifying marks in AYUSH NEET-PG 2018 for admission to PG AYUSH Courses, Online registration is enabled for PG AYUSH courses. The revised eligibility for criteria for PG AYUSH courses as issued by the department is hosted on the KEA Website.
2. The candidates who have scored more than or equal to the prescribed minimum score in PG AYUSH NEET 2018 only are eligible to register for PG AYUSH Admissions. Please note that SC/ST/OBC eligibility criteria are applicable to Karnataka SC/ST/OBC candidates only.
3. The candidates who were eligible but not registered with KEA can also register through online and attend the document verification with all the necessary original documents. (Details of original documents to be produced are detailed in PG AYUSH Information Bulletin-2018)
4. In-service candidates if any will also have to register online and attend the document verification as per the schedule. (With department letter)

NOTE: All other instructions and guidelines is as per earlier notification and PG AYUSH Information Bulletin-2018.
