NOTICE

Providing Scribe for Blind / Partial Blind applied candidates for Competitive Examination – RDPR – 2016 (Recruitment of Panchayath Development Officer and Grama Panchayath Secretary – Grade-1)

INSTRUCTIONS

Stage-1 – Entry of details for scribe through Online.

Note: The qualification of the scribe should not be higher than the qualification prescribed for this post.

1. As per the Government Order, Blind and Partial Blind candidates are eligible to obtain Scribe for Competitive Examination with the prior permission from the examination conducting authority.
2. To enter the scribe details, Blind / Partial Blind candidates have to first enter their application ID and Date of Birth on the KEA Website by selecting appropriate link.
3. After validating the data, an OTP will be sent to the candidate's already registered mobile number.
4. Then, they have to enter the details of scribe such as scribe name, scribe mobile number, scribe postal address, scribes qualification etc. The scribes photo and signature also needs to be uploaded.
5. Select the declaration and submit.
6. Take the print out of the scribe application form and produce the same at the time of medical examination.

Stage-2 - Medical Examination at KEA, Bangalore

1. Medical examination will be conducted at KEA, Bangalore to the Blind / Partial Blind candidates who have entered the scribe details online.

2. Such candidates have to appear before the medical board along with all the necessary medical certificates and with a printout of the online scribe application form.
3. The decision of the medical board is final in deciding the disability.
4. The list of eligible and not-eligible candidates will be hosted on the KEA Website for the information of the candidates.
5. The candidates who become eligible after medical examination will be permitted to obtain scribe for Competitive Examination.
6. The Blind / Partial Blind candidate who becomes ineligible after medical examination will have to pay the application fees as per their category.

NOTE:

1. The other Physically Disabled candidates need not appear and apply for medical examination at this stage as this medical examination will be conducted only for Blind and Partial Blind candidates.
2. The dates for medical examination for Blind and Partial blind candidates will be notified on the KEA Website at a later date.
3. If any Blind or Partial Blind candidates are not willing to obtain the scribe, they need not enter the details online but they have to compulsorily appear for medical examination.

Candidates have to bring the following documents / certificates for medical examination.

1. Copy of the Final print out of the online application form.
2. Copy of the Print out of the scribe application form.
3. Medical Certificate issued by the Competent Authority.

PLEASE NOTE: The blind / partial blind candidate who fails to enter the details of scribe through online and / or who fails to appear for medical examination will not be permitted to avail the facility of the scribe.
